ATTENTION BIKE RIDERS OF ALL AGES!

The Talent Police Department and Talent City Hall will now be issuing bike licenses to all riders within the city limits. **Ordinance 543 Section 38** states that no person who resides in the City shall operate a bicycle on a street or public right-of-way without a current, valid bicycle license. Our goal is to help you find your bike if its been stolen, or to find *you* if your bike has been


recovered. There is no cost to have your bicycle registered – all you have to do is fill out a registration card and inform the police department when your personal information changes. When you come to get your license, make sure to bring your bicycle with you!
