# Talent Fire Service and Fire District Five Annexation

ballot measure was the topic at the meeting of the city council and fire district board.

The final outcome was that both governing bodies instructed their respective attorneys to write a ballot measure for the November election. Both city voters and the patrons of District Five have to approve the measure for the annexation to take place.

After hearing from audience members who wanted to talk

about annexation, the board members discussed:

- A proposed budget based on how Fire District Five would spend the money added to their budget from the city. It includes a new Fire Marshal position, student fire fighters and adoption of the remaining Talent volunteers. That budget is available at City Hall.
- Whether or not the newly enlarged district should be divided into sub-districts for board elections or if members would still be elected at large.
- A name change for the new fire protection entity.

It was finally decided that the ballot wording would be about cost of annexation only and including the cost to city property owners of \$3.19 per thousand. That's the maximum amount the fire district can levy without an extra serial levy under current State of Oregon property tax statutes.

The other issues will be decided by the Fire District Five board after, and if, the annexation is approved by the voters.

The option of a city fire department, employing a combination of paid, student

and volunteers, was rejected in the May election.

Currently Fire District Five administers the city's fire protection services under a one year contract.
