One of the violations I see quite frequently is making a left turn, **without yielding**, at a traffic light. Take for instance, the light at West Valley View Road and South Pacific Highway. A vehicle that is stopped on W. Valley View on either side of the highway (westbound or eastbound), preparing to make a left onto S. Pacific Hwy at the green light, **MUST** yield to oncoming traffic

Grant Awarded for Pedestrian Bridges

At the September 19, 2001 meeting of the City Council, Mayor Telerski announced the City of Talent had been awarded a \$32,000 grant for the **engineering** and **design** of two pedestrian bridges. The Talent Pedestrian Bridges project proposes to enhance access for non-motorized travelers between commercial. residential and recreational areas while improving safety for pedestrians and bicyclists traveling between the greenway facilities and the community. Funds for this grant have been made available through the Forest Service Pacific Northwest Assistance efforts and the Department of the Interior and **Related Agencies Appropriations** Act, 2001.
