Down By the Riverside Cleanup

The 4th annual *Down By the Riverside* clean up is scheduled, rain or shine, for May 18, 2002, from 9 a.m. to 1 p.m. at Lynn Newbry Park. The City of Talent Planning Department and Stop Oregon and Litter and Vandalism (SOLV), a statewide organization dedicated to helping Oregon communities improve neighborhoods and public spaces, is teaming up once again to beautify the park. Over the last three years, over 40 volunteers have helped clean up, plant trees, and remove non-native vegetation. This year, the City plans to mulch trees, remove blackberries, pick up litter, and educate the public about the value of the Bear and Wagner Creek Greenway system in Talent. "Cop Talk"

I want to clear something up regarding fix-it tickets. I hear a lot of people say, "Oh, that's only a fix-it ticket." What you may not know is that it may only be a fix-it ticket *now*, but if you wait long enough, that won't be the case.

If you are stopped by the police for a violation, the officer may issue you a "fix-it" ticket at his/her discretion. A "fix-it" ticket means that the violation needs to be fixed and signed off by a police officer **prior** to your court date. If your court date passes and you have neglected to fix your violation, your "fix-it" ticket becomes a regular ticket and fines will be imposed. For example, if your headlight is out on your vehicle and you are stopped by the police, the officer may choose to issue you a "fix-it" ticket, meaning you would need to have the violation fixed and signed off by an officer *before* your court date. Like I said before, if you wait until your court date passes, your "fix-it" ticket becomes a citation for Operation without Required Lighting, a fine of \$109.

A good rule of thumb: if you have a violation on your vehicle that needs to be fixed, fix it.

Site Plan Review of four manufactured units on four lots for individual lease, Applicant: Doug Vargas, 597 Rapp Road; granted a continuance before Planning Commission on April 25, 2002.

A pre-application conference was held with Batzer Design Build to discuss a proposed large retail center on North Pacific Highway. The applicant is proposing 100,000 square feet of commercial space in a C-3 Retail-Wholesale Zone. The proposed use is permitted subject to approval criteria, including the large retail design standards.

Policies Under Review:

The City Planner has developed a draft version of a new sign ordinance. After two study sessions, a first draft version will be presented at a public hearing before the Planning Commission on April 25, 2002.

Urban Renewal Hires Executive Director

The Urban Renewal Agency (URA) of the City of Talent has hired Marla Cates, long-time civic volunteer and local business owner, as its Executive Director. She will be responsible for overseeing the Agency's urban renewal projects in the downtown area, including infrastructure and economic development projects. If her name sounds familiar, it's because she has served as chair of the Talent Architectural Review Committee, Economic Development Committee, and Community Center Restoration Commission, and was a co-founder of the Talent Historical Society and Talent Enhancement Day.
