THE FLASH'S LAST ISSUE

Starting in June you will no longer receive a copy of the Flash in your mail box the first week of each month. All the news that would normally appear in the Flash will instead be included in the Talent News & Review that will be mailed to your home. This newspaper is new to Talent and the publisher and the City Council have decided to work together to provide the same information to you in the newspaper format. City staff will continue to prepare the articles related to City information and the newspaper will set aside pages within each monthly edition for this information. We will still continue to have the Flash on the City's website monthly. It is intended that both the City and the newspaper will benefit from this combined effort. While the City continues to be committed to provide all the information that we think is important to you, this offers us an opportunity to reduce some of our expenses.

The City will retain editorial control over the articles that it writes. The City pays about \$900 per month for the printing and mailing of the Flash and this expense can be reduced to \$500 a month. The City welcomes the Talent News & Review to the community and is hopeful that this new relationship will be a better service to all Talent Citizens.

OPEN MIC OPPORTUNITY FOR NEW ARTISTS

While any musical genre can apply, the content of the material must be suitable for a general audience that includes young children. Deadline for signing up is June 15th. COMMISSION OPENING

There is a vacancy on the Planning Commission that is open to any City resident. The Commission meets on the 4th Thursday of the month. The Commission reviews development proposals for compliance to the codes and also spends time making/rewriting existing code for City Council consideration.

BUILDING INSPECTION PROGRAM FEE INCREASES

A number of years ago the City of Talent decided to administer and enforce a building inspection program for all building construction within the City limits. This program requires that anyone doing any type of building, either new construction or renovation, obtain a building permit. The permits cover structural, mechanical, fire/life safety, energy, disabled access and manufactured dwellings. While the City contracts with Jackson County to administer this program the building inspectors work out of offices at Talent City Hall. The State permits the City to charge fees that will totally cover the costs for operating this program. The fees include not only the contract price to the County but City staff expenses related to the administration of this program and other operating costs. It has been over ten years since any of the fees have been adjusted in Talent. It is in the interest of the City that these fees cover costs and at the same time are competitive to the fees charged by other cities in the Rogue Valley.

A City Ordinance to adjust these fees will be presented to the City Council for public comment at the May 21st meeting of the Council to be held at the Community Center at 206 E. Main at 6:30 p.m. The entire list of fee changes can be viewed at City Hall in the Community Development Office. If approved the fees would go into effect one month from the date of adoption of June 21st.

SUMMER RECREATION PROGRAMS

Outdoor Activities Need Increased Awareness. As the weather improves and we all spend headgear regardless of age]. more time outside, I'd like to call attention to a variety of issues that need greater attention. I've included below some discussion and relevant web sites. Please use these sites to do your own research. If you do not have access to the internet, please give us a call if you have questions about any of these topics.

First off, we're seeing some unsafe with these noisy problems, many activity on wheels, mostly by children. The following site is Chapter 814 of the Oregon Revised Statutes, which is the state law that for assistance. Call us. covers usage of things like mopeds, bicycles, motor-assisted scooters, skateboards, scooters, and in-line skates: www.leg.state. or.us/ors/814. In this chapter you will find the legal requirements for operating a motor-assisted scooter (such as: must be at least 16 to operate and must wear protective headgear), as well as protective headgear requirements for bicycles, skateboards, scooters, and inline skates (under age 16 must wear). [Note: Talent City

Ordinance requires that all Skate Park users must wear protective Second is the increasing number of noise complaints we're getting, from barking dogs to late night festivities.

Please refer to the Talent City Ordinance #749 – Nuisances, Section 16 addresses "Noises – Unnecessary": www.cityoftalent. org, click the Ordinances link and "N" for Noise. When faced citizens handle these issues just fine with their neighbors, while others will need to call the police

Third, warm weather brings out the swimming pools. Swimming pools, whether they are in-ground or aboveground, as well as spas and hot tubs, must have a barrier around them to prevent children and others from wandering into them and drowning. The specific requirements for these barriers are found in Oregon Residential Specialty Code, Appendix G, which can be found online at www2. iccsafe.org/states/oregon/ Residential/Res_Frameset

Finally, the nice weather also seems to bring out door-to-door vendors and salespeople. The City of Talent has a Peddlers Ordinance that requires an individual to get a permit to sell doortodoor. This requirement is entirely separate from the Business License Ordinance If you encounter a doorto-door seller, ask to see their Peddler's Permit. If they don't have one, call the Police Department and let us know about this activity. As a reminder, we are permanently in our new and improved facility at 604 Talent Avenue. Stop by and see us at the new police station. We are very grateful for this excellent new building. On behalf of the entire Talent Police Department staff I thank the taxpayers of Talent for this very much-needed facility. As always, you can reach a Talent Police Officer 24/7 by calling 911 in emergencies, and in other cases by calling 776-7206 to reach our Dispatching Center. For administrative issues that don't require immediate attention, call 535-1253. If no one answers, leave a message and we'll get back to you as soon as possible.

PLANNING DEPARTMENT NEWS

PUD Appeal Denied

'Pacific Stage Heights' has received a second rejection. The hearings officer issued a decision on 4/7 upholding the Planning Commission's earlier denial of the 143-lot residential planned unit development. 'Pacific' was to be located at the southeast end of town, across the tracks and off Belmont Road.

The basis for his decision was the uncertainty of access. Belmont Road would be the only public railroad crossing for the area southwest of the tracks until reaching W. Rapp Road. The applicant, Artner Construction, argued that they had a crossing further east, where the old route of Pacific Stage Road crosses the railroad, that was suitable for emergency secondary access. They proposed to phase their

project to coincide with improved secondary access, such as when a new street is built connecting Rapp to Belmont.

The hearings officer was not persuaded by their arguments, finding that their ability to use the old Pacific Stage Road crossing was debatable. That coupled with the uncertainty of when a new street is built that would solve the two-access requirementmade it "too tenuous to make a determination that two accesses will be feasible for the initial phases."

On the other disputed issue—**density**—the hearings officer rejected the Planning Commission's finding that there were too many lots being proposed.

<u>Early Agency Sunset:</u> The City Council has asked the Urban Renewal Agency to sunset in 2016, three years earlier than originally planned, as long as the Agency is still able to build the North Talent Avenue and West Valley View street projects. After working out a variety of scenarios and projections, the Agency has determined this will be possible. Although an early sunset will reduce the Agency's overall project-producing ability by about \$1.2 million, there should be enough funds to accomplish these key projects as well as the popular rehab/facade improvement grant and a few other smaller projects.

Next steps on West Valley View Master Plan: After a brief hiatus, the Agency is beginning to move forward with next steps on this project. With the traffic and parking analysis completed last fall, and a state grant recently becoming finalized, the Agency will soon solicit proposals for a project engineer. It is anticipated the engineer will begin surveying and other pre-engineering work this summer. In addition, a design team will be selected to begin work on streetscape concepts, with an eye to involving the public. If you would like to be on the "interested party" mailing list for periodic project updates (but haven't signed up yet), please contact the Agency.
