Talent PD News By Chief Mike Moran

The transition to a merged dispatch center has been in place for over one year. But the changes keep coming. We are now in the beginning of a transition to a new report writing and records keeping system. There may be some bumpy spots in this but we will work through the issues.

October is a time where morning driving conditions are not ideal for seeing youngsters going to school. The Daylight Savings Time makes for longer daylight after work but cause dark mornings after some kids are on their way to school. Please use caution!

Standard time returns the first Sunday in November.

I have been asked recently about Grand Jury and how it works. In the State of Oregon, a person can be arrested without warrant if an officer sees a crime being committed or if he or she has probable cause to believe a crime was committed. If the crime is a misdemeanor the person is given an appearance date to appear for trial.

In a felony matter, a case is often presented to a Grand Jury before an arrest is made to obtain an indictment and an arrest warrant. The Grand Jury also hears cases presented regarding people already arrested and the Grand Jury is then asked to indict the person.

The Grand Jury is made up of 7 Jackson County citizens. They listen to a presentation of facts by the investigating officer, the victim and witnesses. If 5 of the 7 feel the facts warrant it, a True Bill is returned and the suspect is indicted.

You could be chosen to serve on the Grand Jury as the process is similar to being chosen to serve in a regular courtroom jury. It used to be that only registered voters were in the jury pool. Now, DMV records are also used to compile a list of potential jurors.

It is an honor and civic duty to be asked to serve on a jury and it is a key component in our criminal justice system.

What to do with all of your leaves? Here are some ideas:

• Spread as mulch on your yard or add to your compost

• Deliver to someone who wants them. The leaf exchange program operated by the Air Quality Program for Jackson County maintains a list of donors and interested recipients. Call Lynn at 541-774-8207 for information. (The Fry family of the Fry Family Farm in Talent wants your leaves, call them directly at 535-8044)

• Drop off plastic bags of leaves for free at the Recology Recycling Station on Water St. in Ashland on one of 3 Sundays later this fall, November 6, November 20, and December 4 from 9-5 where they will be taken for composting. If you want to drive a bit further, you can drop off yard waste including leaves free of charge daily at the Rogue Disposal Recycling Station at 8001 Table Rock Rd in White City.

• Have them picked up at curbside by using compostable leaf bags in November and December. These special leaf bags may be purchased from Recology at a discounted price of \$10 for 5 bags at their office: 170 Oak St in Ashland. These will magically turn into compost as well.

News from the Parks Commission

If you are a Dog Park user, you've probably wondered what happened to all those benches, tables, chairs and pools, that were there one day and gone the next.

First of all, we would like to thank everyone, who enthusiastically brought their extra chairs and extra doggy bowls to share!

Unfortunately, we cannot keep all those items in the park, due to liability issues. Chairs need to be City approved, for safety reasons. An array of doggy bowls have been found tossed by the wind or other unknown forces onto Talent Avenue, and the pools simply didn't last long, because of complaints.

If you want to bring something of your own to use at the park, remember to take it home with you. If you have brought something to the Bark Park that has been removed by the City, please contact City Hall or Public Works to pick it up.

News from the Planning Department

Sign Ordinance Amendment -Public Art:

On October 19th, 2011 the City Council will hold a public hearing to discuss an amendment to the Talent Sign Ordinance exempting public art from being considered a sign as long as such art is first approved by the City Council. As defined, signs are anything ranging from a mural to a figurine, including various art mediums. By exempting public art from the sign ordinance, property owners and citizens can petition the Council for consideration.

Flood Insurance – Prior to the Rains

The City of Talent participates in the National Flood Insurance Program (NFIP) that makes available federally backed flood insurance for all structures, whether or not they are located within the floodplain. More than 25 percent of NFIP claims are filed by properties located outside the 100-year floodplain, also known as the Special Flood Hazard Area (SFHA). Following the purchase of flood insurance, NFIP imposes a 30-day waiting period, so residents should purchase insurance before the onset of the rainy season to ensure coverage during the flooding season. Please be aware that standard homeowner or renter insurance policies do not cover losses due to flooding. Before a person can receive a loan or other financial assistance, there must be a check to see if the building is in a Special Flood Hazard Area (SFHA). The SFHA is the base (100-year) floodplain mapped on a Flood Insurance Rate Map (FIRM). It is shown as one or more zones that begin with the letter "A" of "V". Copies of the FIRM are available for review in the City's Planning Office. Many lenders and insurance agents also have copies. It is the agency's or the lender's responsibility to check the FIRM to determine if the building is in an SFHA, although the City will provide assistance. Old Theater Relocation:

The old Camelot Theater was purchased in 2009 by the Agency to make way for the extension of Main Street in 2012. Subsequently, Talent resident Chris LaDue stepped forward to acquire and relocate the building to property on Wagner Creek Road. As of this writing, the metal beams required for the move have been crafted and are on site, and preliminary prep work for the move is anticipated to follow.

Façade Improvement Grant for new Simply Sassy site:

The Agency recently authorized a grant to assist a facade improvement project at 100 West Valley View, the former site of Paradise in Bloom (which has moved to Market Street) and the new site of Simply Sassy salon, a long time downtown business. Watch for a new front door, rear access ramp, and signage designed to mimic original window openings in this vintage building, part of the original 1930's Talent Auto Court.

Seiber Street Now Complete:

The first phase of the West Valley View project, Seiber Street, is now complete. General clean up and a few last minutes touches still remain to be done, but the street is now fully accessible for parking behind the new Camelot theater. For the next year, Seiber Street must be entered via New Street (near Umpqua Bank). To exit, use the turnaround and exit via New Street, or exit via the one-way alley north of the new theater.

Camelot "Recycles" Its Annex:


